Between the crisis and disaster management units Faculties of Veterinary Medicine and Agriculture Cairo University

**Second:** Faculty of Agriculture Cairo University based in Giza. It is legally represented by **Prof. Dr. Sameh Abdel Fattah** as Dean of the College (Second Party) After acknowledging the validity of the data received, the parties, as they were in the cooperation protocol, agreed to:

#### **Boot**

Crisis and disaster management is one of the most important security and security requirements for educational facilities related to large human numbers and infrastructure with the potential to be maintained as one of the key elements for establishing quality requirements in that institution. Responding to crises and emergencies, whether by preparing for them, anticipating them, or dealing with them if they occur, places the greatest burden on college crisis and disaster management units in this area to ensure full protection for individuals and facilities and to develop a comprehensive disaster and emergency plan for educational institutions.

In order to develop the effective performance of crisis and disaster management and work to implement plans and programs designed to ensure the working environment to provide security and safety in the college facilities and reduce the negative risks and effects of crises and disasters in pursuit of internal community stability and in line with the great development in these areas, the parties agreed to cooperate with each other to achieve this purpose and agreed to regulate that protocol according to:

#### Item 1

### Boot is an integral part of the protocol

The previous preface is an integral part of this protocol in understanding its provisions and interpreting its provisions.

### Item 2

### Subject of protocol

The parties cooperate in managing crises and disasters to which the colleges may be exposed, God forbid, in accordance with the national crisis management system in its three stages, namely, the first phase: pre-crisis, phase II: during the crisis (confrontation and containment) and the third phase: post-crisis (balance phase).

### 2/1 - Cooperation in the pre-crisis phase:

- Joint planning (forecasting/forecasting of potential crises and disasters in one or both colleges in the near/medium/long term).
- Cooperation in preparing plans and drawing up scenarios for crisis resolution and disaster response.
- Join hands in taking preventive measures to prevent a crisis or disaster in both colleges.
- Joint readiness to deal with events such as personnel training and equipment maintenance.
- Contribute to spreading cultural awareness of crisis and disaster management among the community of the two colleges and holding joint training workshops to improve the competence of the staff of the two colleges in this field.
- Joint development of monitoring and early warning mechanisms in crisis and disaster management
- Equipping a joint crisis and disaster management operations room equipped with appropriate communication devices in the event of joint crises between the two colleges or the use of distinguished competencies experienced from the community of the colleges in the event of a crisis in one of the colleges.

# 2/2 - Cooperation at the crisis stage:

- Synergy in the implementation of individual or joint plans and scenarios that have already been prepared and trained.
- Cooperation in the implementation of confrontation and relief work of all kinds in accordance with the quality of the crisis or disaster.

- Participating in the work of emergency services.
- Join hands in carrying out evictions when necessary.
- Follow up on the event, see the developments of the situation on an ongoing basis, evaluate it, and identify the procedures required to deal with it through the Joint Operations Room.

### 2/3 - Cooperation at the post-crisis stage:

- Joint support between the two colleges to account for losses to individuals and facilities.
- Cooperation in rehabilitation and reconstruction (resumption of activity) and protection from potential future hazards in accordance with the possibilities of each college.
- Joint assessment of actions taken to deal with the disaster during the confrontation, response, containment, lessons learned and exchange of experiences.
- Joint documentation of the event and the submission of the necessary recommendations and proposals and directed to the relevant authorities to benefit from them to avoid the negatives in the future (if any) and develop the modernization of plans for better management.

## <u>Item 3</u>

### **Duration of protocol**

The duration of this protocol is a calendar year starting from April 1, 2022, and ending on April 1, 2023, renewable for other similar periods automatically unless one of the other parties is notified of a letter recommended with access science or hand-delivered in exchange for a receipt that he does not wish to renew, if it is before the end of the protocol or any specified periods of at least two months.
